I, Susan E. Lee, declare:

1. I an associate with the law firm of Winston & Strawn LLP, counsel of record for Defendant, Google Inc. ("Google") in this action. The statements contained herein are based on my own personal knowledge. On September 25 and September 26, 2005, I typed into a web browser the 35 URLs listed on Exhibit 81 of the Declaration of Norman Zada for which Perfect 10 provided a complete URL address (i.e., without ellipses) and which Google's records indicated may not have been processed.

2. Of these 35 URLs, at least ten were not active or did not contain images of women other than images that have no apparent connection to rights asserted by Perfect 10. At least two of the ten URLs redirected to a web site, which
